VETERINARY REPORT FOR 'TCHAIKOVSY'

Signalment: 4-Year-Old Bay Thoroughbred Gelding

Microchip: 985100012101685

Brands: NSS: JOCKEY CAP OVER THREE CONJOINED DIAMONDS
 OSS: 17 OVER 5

'Tchaikovsky' sustained wounds to the left hind dorsal mid cannon and left fore lateral cannon on the 16th June 2019 at the spelling farm. The left fore wound healed without complication but radiographs of the left hind cannon revealed the formation of a bone sequestrum. This sequestrum was removed under standing sedation on 4th July 2019, and the wound has since been healing satisfactorily.

On examination on the 2nd August 2019 at Oak Ridge spelling farm, the gelding was trotting without any notable lameness. A moderate sized (approximately 10cm x 10cm) wound with a healthy granulation bed was present on the left hind mid dorsal cannon.

This examination was performed for James Harron Bloodstock and is only valid for findings on the 2nd August 2019 and cannot predict changes after this date.
