Arthroscopic surgical removal of osteochondritis dissecans (OCD) fragments of right hock as a yearling.

07-03-2018

Arthroscopic surgical exploration of left hock as a yearling.

Fibrocartilage was debrided and removed. 3 small bone fragments in the distal aspect of the joint were identified on radiographs, but these small bone fragments were embedded in the soft tissue lining of the joint and could not be visualised for removal.

23-10-2019

Mild lameness of right hindlimb. Radiographs revealed some ligament pulling of pastern.

20-02-2020

Radiographs taken of the right hind pastern revealed an old periosteal reaction of the distal 1st phalanx (long pastern) and the proximal 2nd phalanx (short pastern).

No other significant veterinary issues have occurred with this gelding while in training with Godolphin.
