On the 10<sup>th</sup> of July 2025 'Imperial State' underwent a standard pre-sale resting upper airway endoscopic examination at the Rosehill Stables of Gerald Ryan & Sterling Alexiou.

The scope was performed with a twitch. Full abduction of the arytenoids was achieved after swallowing (grade I/IV laryngeal function - Havemeyer scale).
